Operation Strike Back - Feedback

I received several good recollections of operation Strike Back that appeared in our October 2009 newsletter. If anyone else remembers this operation, I would like to hear from you. If you lost your copy, it is posted on our website.

Reference Oct. 2009 issue. I was on the Weeks from Jan 1957 until March of 1959. I remember the Operation Strike Back. We took a better than 60 degree roll in the Irish Sea, lost engines for a short time. a 2nd class MM who was taking the 1st class test on the mess decks left his test and got to the engine room and helped reestablish power. We also lost an anchor in Dundee, Scotland.

We lost the anchor because there was a mix-up in the length of anchor chain. One anchor had longer chain than the other one. As the anchor was being let out they realized, too late to stop, that the shorter chain was at play. Ergo, the anchor and chain are, I imagine, still resting at the bottom of the Firth of Clyde, off Dundee. Capt. Lovejoy, at one of our reunions, told me that an admiral gave him some grief over the incident.

I read the newsletter story about the NATO cruise in '57. I remember parts of it very well. I'll tell you a story re: the Wasp. We had a Chief EM I don't remember his last name but I think his first name was "Jack" because we called him "Smilin' Jack". He had a very nervous twitch and was very nervous. He said it was from some kind of welding accident-the flash got him or something. He was a nice guy and smiled a lot (hence his nickname). Anyway, when he heard we were operating with the Wasp he was very upset. It seems that the Wasp hit at least one (maybe two) "cans" and one collision resulted in the death(s) of his old shipmate(s). He was scared to death of the Wasp. He called it the "can opener". When he heard of the near miss he was mortified. Really scared and he scared us. I think Ltjg. Brock was the O.D. and he saved the ship (and us) by taking evasive action at the last minute-we heard. I also remember Liberty in Scotland and Cherbourg France. We all had a 3 day "basket leave". I used to "stand by" for the married guys when in Norfolk and one or two of them offered to give me their "basket leave" so I could go to Paris and London. Our Division officer (Mr. Bennett) said this wasn't possible so I chose Paris over London; I think this was the way it went.

I remember the Russian trawlers cutting in and out between our ships. They were "ratty" looking but had all types of antennas and radar gear on them. I didn't know the Nautilus was there. It seems that the lowa was with us also. I remember we went close to Norway and could see it in the distance-that's as close to a "Northern Europe cruise" that we got (always heard they were great).

I hope I got these facts straight. I may have mixed them up but I don't think so. We anchored in the Firth of Forth I think in Scotland. I seem to remember the name Dunedin and always thought that was the town.

Did you know that there was another ship named John W Weeks?



Every so often I get an email from someone that discovers our website and tells me about their father or grandfather who served on a ship named the John W Weeks. And the person will tell me that there were army troops on the ship crossing the Pacific during WWII. I thought that was strange since I didn't recall hearing anything from our WWII shipmates about carrying troops and I couldn't find anything in the ship's logs for that time period. I did a search and found that a Self-propelled Barracks Ship was laid down, 9 December 1942, as SS John W. Weeks and launched, 2 January 1943. It was delivered to the War Shipping Administration for operation under contract to the US Army Transportation Service. The ship was acquired by the US Navy in 1951 and placed in service as DuPage (APB-51). Later it was placed out of service (date unknown) and returned to the Maritime Administration for disposal. Final disposition, scrapped in 1959 period.

Does anyone remember this accident in the fifties from Paul Hutko?







